TERMS & CONDITIONS OF USE OF GARAGE

DEFINITIONS:

QR:	Willowbank Race Circuit Pty Limited trading as Queensland Raceway
QRG:	The entity responsible for the management and upkeep of Garaging
Garaging:	The buildings & environs set up by QRG to store race vehicles
Bay(s):	An area set aside for use by me within Garaging
Garaging Fee:	The fee set and published by QRG for use of Bay(s) within garaging
Period:	The period for which I will have use of the bay and shown above.

I agree & accept:

1. My use of the bay(s) is granted to me by QRG as a non-exclusive license to use it for garaging purposes. The license is personal to myself and may not be assigned or sub-let to anybody else. If I share the area with anyone else then I am responsible for any actions and/or damage they may cause.
2. I will lodge a security deposit of \$25.00 for each bay to ensure that I perform my obligations under this agreement. QRG may use the security deposit to reimburse any expenses incurred by QRG as a result of any action or inaction by me. I accept that my deposit may NOT BE REFUNDED until the key has been returned and the bay(s) have been inspected.
3. QRG is in no way liable for anything placed or stored in garaging nor does QRG accept any responsibility for any loss or damage that may occur to goods in garaging regardless of how the loss or damage is caused be it QRG's negligence or otherwise.
I ACKNOWLEDGE THAT I HAVE BEEN ADVISED BY QRG TO EFFECT A POLICY OF INSURANCE UPON MY GOODS TO COVER ME AGAINST ANY LOSS OR DAMAGE DIRECT OR CONSEQUENTIAL THAT MAY ARISE FROM DAMAGE OR LOSS OF THE GOODS.
4. Whilst using the garage, I will:
 - Keep the bay(s) clean & tidy
 - Minimise the build up of exhaust fumes inside the buildings
 - Use only tape, bluetak or the brackets provided for the attachment of signage
 - Respect the needs and privacy of others using the facility
5. Whilst using the garage I will **NOT**:
 - Store or place quantities of fuel or other volatile liquids inside the buildings
 - Weld, braze or light any fire (including barbecues) within the building
 - Write on, deface, or affix anything to the walls, floors or ceilings
 - Drill holes in or cause ANY other damage to Garaging
 - Allow oil, grease, mud, gravel, etc, to remain on the floor of the bay
 - Change, modify, move or in any way tamper with the internal dividers
6. I am responsible for the costs of making good any damage caused by MY action or inaction. I am responsible for the removal of rubbish from the bay and agree to pay a Rubbish Removal Fee of any items I leave in the bay or the common area of the complex.
7. On or before leaving the bay I will:
 - Pay all garaging fees UP TO THE TIME OF RETURNING THE KEY
 - Leave the bay completely empty and swept out
 - Return the key to QRG's office
8. I accept that QRG may enter the bay(s) to ensure observance of this agreement and that QRG may terminate this agreement at any time and for any reason in which case I agree to leave garaging quietly and immediately.
9. Notice(s) regarding this agreement may be sent to me as a letter by prepaid ordinary post to the address I have given overleaf and shall be deemed to be received by me two days after posting.
